- c) County Fire Department – Battalion Chief Michael Westfall discussed security concerns at Fire Station 76. He shared concerns from the firefighters and the community regarding activity in or around the fire station including:
  - 1. Many cases of illegal activity including prostitution and drug use on the property since there is not adequate lighting or security fencing.
  - 2. Recent rise of transient population around the station
    - a. The homeless population have vandalized the property and building.
    - b. Transients have dug under the fence and shattered the windows of the fire station.

Fire station personnel has asked for support from Supervisor Baca Jr. to approve a new fence that would prevent unauthorized people from getting in the station.
