 - i. The month of May accumulated approximately 747 calls for service.
 - ii. 24 Domestic Violence calls
 - iii. 2 Assault with a deadly weapon
 - iv. 1 Attempted murder
 - v. 1 Armed Robbery
 - vi. There was a grand theft auto call. The police arrived on scene and began to canvas the area within approximately 20 mins the suspect who matched the description in which the care was located was taken into custody without incident.
 - vii. The vehicle was returned to the owner.

- viii. The attempted murder call was an incident where the suspect showed up to the victim's significant others home early in the morning. The victim was trying to leave the residence, and an altercation occurred.
- ix. The victim was stabbed approximately 7 times.
- x. The victim was rushed to the hospital.
- xi. Deputies arrived on scene where they were given the identification of the suspect.
- xii. The suspect turned themselves in.
- xiii. The domestic violence call for service is the most calls received this month.
- xiv. A domestic violence call was made on June 1, 2023, because a male subject was trying to force a female into the car at the Pilot gas station on Cedar.
- xv. The clerk called 911.
- xvi. While police were arriving at the scene the suspect fled the area, and the victim was able to get away.
- xvii. Due to a thorough investigation from the deputies, they were able to get a good interview and surveillance which assisted with the identification of the suspect.
- xviii. The police were able to locate the suspect.
- xix. The suspect led them on a short vehicle pursuit, which was terminated due to public safety concerns.
- xx. The suspect will be apprehended soon.
- xxi. There are a ton of resources offered to victims of domestic violence throughout the county.
- xxii. If you have any reason to believe someone may be a victim, please call it in.
- xxiii. Local Law Enforcement Agencies: Rialto Police Department, Fontana USD, Fontana Police Department, Fontana Sheriff Station, and Rancho Cucamonga participated in the Special Olympics to raise awareness.
