# 3. AGENCY STAFF REPORTS (3-5 Minutes)

- a) Supervisor Joe Baca, Jr.'s Office Jessica Andalon Extended gratitude to those who participated in our Earth Day event, as well as to our partners, Senator Eloise Reyes-Garcia's office and Assemblymember Robert Gracia. She also conveyed appreciation to nurses and teachers in recognition of Appreciation Week and congratulated all graduates of 2025.
- b) State Legislative Update Ulysses, the Field Representative, provided an update stating that Assemblymember Garcia has been appointed to the Housing Committee. They plan to approach Vice-Chair Baca, Jr., for potential opportunities in Bloomington, which are yet to be determined. The focus will be on affordable rentals and pathways to homeownership. All of his bills are progressing, and he will share more details when they become available. Additionally, he mentioned that he will have his business cards on hand.

- d) Code Enforcement Encouraged the community to report illegal dumping, unpermitted construction, and other issues by calling 909-884-4056, with the option to remain anonymous. They noted illegal dumping on Mapel Street and are actively working to resolve the situation. Additionally, they are collaborating with the owner of Dollar Tree to establish a "No Trespassing" sign/contract. The Community Dump Day, which took place on the same day as Earth Day, successfully filled seven dumpsters and three front-loader trash cans.

- g) Sheriff Department Captain Thies introduced the new deputy, Mark Martinez, who has 29 years of experience as a deputy. Mark's mother was the secretary at Bloomington High, and he expressed his happiness to be assigned to Bloomington. Captain Thies also shared that on April 29th, Bloomington received a bomb threat; however, no evidence was found. A student was identified as being responsible for the threat and has been cited.
- h) Special District Aaron Speer Earth Day was a success. The Mother's Day Succulent Class, held in partnership with West Valley, was also a hit, attracting over 30 participants. CJUSD has been a fantastic partner, as they Special Districts allowed the use of Kessler Field for their last three games, including Senior Night. Park hours are being adjusted to help deter graffiti. We hope to have a brochure available by the end of the month detailing all the activities that will be offered. On June 6th, we will host our first Senior Prom with a 50s theme. The Splash Pad is still awaiting parts, but we are looking forward to a big grand opening. The Dream Field has received positive feedback from the community, with many expressing their appreciation.
- West Valley Water District Expressed gratitude to Aaron for the success of the succulent class. And urged residents to conserve water wherever possible, especially since we had a dry winter.

• Bloomington Road Work Improvement Project- Bob Vezutto

- Locust Avenue is currently closed at Armstrong Road, with an estimated reopening in September 2025.
- Linden Avenue will experience partial closures when school is out, from June 2025 to August 2025.
- Jurupa Avenue will have partial closures from June 2025 to December 2025.

Omnitrans- Informational presentation

Presented by Nicole Ramos, Director of Marketing and Communications, and Ruby Sulca, Mobility Services Coordinator. They provided an overview of Omnitrans through a PowerPoint presentation, detailing services in 15 cities, catering to approximately 7 million passengers annually, and employing 606 staff members.

Also highlighted were various mobility services, including travel training, volunteer driver programs, and Uber riders.
